Treasurers Report

Cathy LaSalandra reported that she is still maintaining a Checking and Savings account in the US and a Checking account in Canada. Her full report is on file with the Secretary and was handed out to all those present at this meeting.

She also reported that we have 5 judging Candidates in the US and 6 in Canada. Letters where sent out for them to receive an allotment if they responded. We have been fortunate to give them \$100.00 each to help defray their costs.

A motion was made by Marj Gillis to approve the treasurer's report. It was seconded by Barbara-Ann MacIntosh. Motion Carried.

Linda Muise reminded us that we should remember to pay Area 2 dues of \$4.00 at the same time that we pay our International Dues. That way nobody would be late.

Finance Committee Report

Recommendations from the Finance Committee

- 1.) That we increase the Area 2 Rep. Travel by \$500.00. Her travel is covered by Area 2 Budget. She only asks for Mileage and Tolls. This will allow her budget to handle all of the trips needed to visit chapters for the year.
- 2.) That we increase the stage managers budget from \$1000.00 to \$1250.00. This would only be for this year to cover expense for 2004. This will help with expenses for assistants such as Joan Noreau who helps back stage and is not part of a chorus at this time. These people volunteer to be a part of this stage team each year.
- 3.) With the AC&C 2004 profit of about \$4000.00, we would like to add an additional \$500.00 this year to the judge's fund. This will allow a total of \$150.00 each.
- 4.) Would like to use \$2000.00 for AC&C 2005 this would take \$5.00 off each all events pass. Taking them from \$80.00 each to \$75.00 each.
- 5.) To increase the Area 2 Rep Travel to \$1800.00 for fiscal year 2005, and \$2000.00 for fiscal 2006.

A motion was made by Barbara-Ann MacIntosh to accept the recommendations of the finance committee. Seconded by Lois Lundsted. Motion Carries.

A motion was made by Betty Dwyer to amend the previous motion to read that we increase the judge's fund to \$1200.00. And accept the rest of the recommendations. Seconded by Marj Gillis. Motion Carries.

2006 Budget

A motion was made By Barbara-Ann MacIntosh to increase the Area 2 Rep budget to \$2000.00. Seconded by Gail Kelsall. Motion Carries.

A motion was made by Barbara-Ann MacIntosh to make a financial policy change to be that a judging candidate may receive up to \$200.00. Seconded by Betty Dwyer. Motion Carries.

ABC Day 2004

September 18th from 9-5 at the Presbyterian Church All Events pass is \$25.00 Canadian This will include, water, snack, and lunch. There will be about 8 different classes. Coaching is available Expenses should not be high. There are a few beds available is needed. There will be 5 to 7 certified judges teaching. It is open to non-harmony members.
