- 2 To purchase a new Area 2 Laptop and Multi Media Printer for the Area 2 rep to use. Motion was made by Sandy Lewis and Seconded By Margaret Bartholomew to spend up to \$2,000.00 for a new laptop and multi media printer for Area 2 rep to use. Motion Carried.
- 3 Credit/Debit Cards finance committee recommends that chapters look into this. That Area 2 look into it further for future discussions. International impressed with Area 1 Airline miles. Gail will contact Susan Tucker to get information from her on her card.
- 4 For your information International has upped it's rates for travel and per diem. We will also to be in sync. The price per mile will now be \$.35 per mile and the per diem will be \$40.00 per day now. These prices are effective as of October 1 for mileage and December 1 for per diem.
- 5 We would like to offer the Judges and Candidates in our area support of \$150.00 each this year. Motion made by Barbara-Ann Mac Intosh and seconded by Suzie Watterson that we offer each Judge and Candidate the amount of \$150.00 for this year. Motion Carried.
