The meeting was called to order with a welcome by Gail and the reciting of the Harmony Creed. Linda Muise directed the council singing of the Harmony Theme Song

Motion by Lois Lundstead and seconded by Donna to accept the minutes from the previous meeting: Motion carried

Gail presented her Area 2 Representative Report. The highlights were:

- 1 Area 2 has the most chapters of any area
- 2 Membership is the key focus of the IBOD for this year Harmony's membership is aging and we need to form some strategies for recruiting more members
- 3 Part of her job description is to visit every chapter and she is finding this difficult. Some suggestions to Gail were to set up mini visitation teams and have them visit chapters, especially those who do not participate and explain to them why they are important to the Area and ask if they need help. Aileen Murray, Barbara Ladabush and Cathy Cuculo volunteered to be the mini visitation team.
- 4 Reminder that by March 31, 2008 all chapters must be incorporated. Incorporation papers should be sent to Executive Secretary.
- 5 Brought up idea of Sister Chapters again
- 6 It is disturbing that some chapters do not have any idea of a hierarchy within Harmony, Inc.
- 7 Wants some ideas on how to get all information to chapter members. In visiting chapters, both she and Aileen Murray, have found that many presidents do not pass on information to their members

Area 2 Treasurer, Cathy La Salandra, presented her report

<u>Motion by Heather Solomon and seconded by Aileen Murray to accept the treasurers report as presented.</u> Motion Carried

Area 2 Advisor, Linda Muise, presented the financial report. ACJC 2008 AC&C Funding—we currently have been double budgeting the Area 2 ACJC on the Area Budget and on the AC&C Budget. Finance committee recommends deleting the line item from the Area Budget starting with the 2008 budget. Also, the line item for photos—finance committee recommends deleting this from the AC&C budget as now that there is digital photography and photos are on the websites, there is no longer any need for hard copy photos for a History Book. This will change the job description of the Historian. New job description to be written after conferring with Dianne Clark re photographer at contest.

Motion by Lois Lundstead and seconded by Sue Staples to remove these two line items starting with the 2008 Budgets. Motion Carried

Finance Committee recommends allocating some monies from our treasury to help defray the cost of all events passes at AC&C 2008.

Motion by Kate Steer and seconded by Cathy La Salandra to use \$3,000 from the Area Treasury to defray the costs of AC&C 2008 all events passes. Motion Carried

Motion by Kate Steer and seconded by Lois Lundstead to send to Study & Review asking the feasibility of using profits from our AC&C's to assist chapter or members financially to attend future AC&C's or perhaps HITS. Motion Carried

Finance committee recommends using funds to assist our Area 2 judges with a check for \$150 (in the funds of their home country) to be used for category school or other

expenses associated with their judging experience. There are 6 certified judges and 2 candidates.

Motion by Aileen Murray and seconded by Barbara Ladabush to accept the finance committee recommendation for assisting Area 2 Judges and Candidates. Motion Carried

AC&C Reports

<u>2007 AC&C</u> – Aileen Murray reported that it went very well, she filed her report and the secretary has a copy should you wish to review it. She reported that every member of the chapter helped in some way. She is requesting an updated AC&C Manual be completed and she offered to assist with it. Attendance was down a little. The silent auction they held was well received. The centerpiece auction also raised more money than anticipated. \$500 was saved on judges' travel.

<u>2008 AC&C – Linda Muise, Chairman</u> Sounds of the Seacoast are hostess and it will be held in Portland Maine. The theme is "Feeling Groovy" the headquarters hotel will be the Marriot at Sable Oaks with the Holiday Inn Express as the overflow. They are looking at one of the 6 high schools in the area to hold the contest in.

2009 AC&C Hostesses are Silk & Sounds and the theme is "Fabulous Fifties"
2010 AC&C Hostesses are Harmony Heritage and it will be held at the Crowne Plaza in Warwick, RI

Motion by Sue Staples and seconded by Donna to accept the bid from New England voices In Harmony for 2011 AC&C Motion Carried Just a reminder that the 2011 AC&C will be May 12-14, not the last full weekend in April
