Insurance for D&O

Kath Morgan spoke to this issue. There has been much discussion on this and some are confused as to whether they want or need this insurance.

The insurance we have now covers our members not our Officers. Kath explained that Harmony, Inc changed insurance agency and found an insurance that specializes in Non-Profit. We should have ad this 10 years ago and didn't get good advice then. It is a safety issue for Chapters to get this insurance the cost of lawyers alone to fight for you in a case would be heavy. It will cover US/CND. Every chapter must buy in to the program. It was discussed that Harmony membership dues increase instead to cover those smaller chapters. This will be discussed at mid year.
