Gail Kelsall welcomed everyone to our first Area 2 Council August conference call meeting.

Approval of Minutes of April 2009 council meeting.

Motion by Heidi Berger and seconded by Sandy Venditti that we approve of the minutes of the April 2009 council meeting. **Motion Carried.**

Agenda is approved with an addition by Linda Janes of a Student Contest at AC&C.

A report of the 50th Anniversary committee Chairman was read by Gayle Jordan. (see attached report)

Finance Report

Heather reported that there will be a large profit from AC&C 2008. The final reported figure is not completed yet but will be in the area of \$10,000.00. The loan of \$1000.00 to Silk'n Sounds and the $\frac{1}{2}$ price AEP for all Silk'n Sound members needs to be refunded to Silk'n Sounds. Final figures will be forthcoming soon.

Having this large figure the Finance Committee met on July 26th via conference call and are making the following recommendations to the Area 2 Council for disbursement of these funds. LCD projector for Area 2 Approx. \$600.00 with \$250.00 return from International for the purchase.

Judges Assistance Fund - \$1,200.00 with those applying receiving \$100.00.

Education Chairman Travel for HITS line item of \$500.00.

Harmony Heritage \$5000.00 to apply to AC&C 2010 to help defray cost of convention.

LCD Projector

After much discussion about how it will be used which will be for Education within the Area and education classes at International. Where it will be housed, which will be with Gayle Jordan until November and then with Gail Kelsall who will place it on her homeowners insurance for coverage. Aileen Murray had found figures above \$600.00 making the purchase in Canada. Gayle Jordan researched in US and found the exact same one that Area 4 had purchased and what we were trying to

find for Area 2 . She found at same price Area 4 paid of \$549.00 before shipping. It was also discussed that we should purchase an addition bulb at the same time.

Motion was made by Heather Solomon and seconded by Aileen Murray that we allocate \$800.00 for the purchase of an Epson LCD Projector and bulb within the US with a \$250.00 reimbursement coming from Harmony, Inc. Motion Carried.

Motion was made by Marj Andrew and seconded by Sandy Anagnostakis that we approve the Finance Committee Recommendations of, \$1200.00 for judge's fund, \$500.00 Education Chairman travel to HITS line item, and \$5000.00 to Harmony Heritage to defray costs of AC&C 2010. Motion Carried.

AC&C 2009 Report

It was reported that a large profit is being reported from Silk'n Sounds. This is out of the ordinary. Grants were attained and convention was based on a lower amount of attendees. Thus making a large profit. The council thanked Silk'n Sounds for the great job and also for working so hard at getting the grants to help defray the costs. They are finalizing their report and will be sending out the report and funds to our Area 2 Treasurer soon.

ABC Days

Capital Chordettes date is September 25, 2010. Please mark your calendars.

Linda Janes reported that Champlain Echoes is considering looking at hostessing and ABC Day for another year. She will talk more with them.

Directors and Officers Insurance

Susan Spencer Finance for International is gathering more info for the IBOD and will be making her report in the middle of Sept, 2009. This insurance will cover your chapter BOD and officers. It will mean an additional \$150.00 per year for each chorus and all chapters must buy into it or it will not happen. More info will be coming soon.

Education Classes on Sunday at AC&C

Linda Janes has gathered information on this subject from a survey given after AC&C and of all the information the outcome is that Craft classes will remain on Friday of convention.

1/2 Price AEP for Website Manager

Aileen Murray reported from Study & Review that this item will not be considered at this time. It was the consensus that all members work for Area 2 in their positions volunteering their time and that no one should be compensated for this work.

Random Draw at AC&C

This was sent to Study & Review. This was an adhoc committee of Aileen Murray, Marj Andrew, and Julie Schwingbeck to discuss this issue. This only affects 5 Chapters in Area 2 and very few members. It was stated that when you decide to become a duel member you understand the rules of this position and that choices may need to be made. The random draw is the Luck of the Draw and is not a choice of draw. After the report of the committee it was decided that there will be no changes to this rule.

Harmony Explosion Camp
